COOLEY, Air Force Materiel Command, Wright-Patterson Air Force Base, Ohio, did, at or near Albuquerque, New Mexico, on or about 12 August 2018, commit sexual contact upon [REDACTED] to wit: causing her to touch, through the clothing, his genitalia with her hand, with an intent to gratify his sexual desire, by causing bodily harm to [REDACTED] to wit: causing her to touch, through the clothing, his genitalia with her hand, without her consent.

Specification 3: In that MAJOR GENERAL WILLIAM T. COOLEY, Air Force Materiel Command, Wright-Patterson Air Force Base, Ohio, did at or near Albuquerque, New Mexico, on or about 12 August 2018, commit sexual contact upon [REDACTED] to wit: touching, through the clothing, her breast and her genitalia with his hand, with an intent to gratify his sexual desire, by causing bodily harm to [REDACTED] to wit: touching, through the clothing, her breast and her genitalia with his hand, without her consent.
